MINUTES TAKEN BY THE CLERK AT THE MEETING OF CARRINGTON PARISH COUNCIL, WHICH WAS HELD ON TUESDAY 25<sup>TH</sup> SEPTEMBER 2018 IN CARRINGTON VILLAGE HALL COMMENCING AT 7.05PM

**Present:** Cllr. A. Paul, Cllr. T. Morgan, Cllr. J Hayes and the clerk, Mrs V Clark.  
Also present: 6 members of the public, County Cllr T. Ashton & District Cllr N. Jones

In the absence of the Chairman and Vice Chairman, Cllr. A. Paul was appointed Chairman of the meeting.

## **THE CHAIRMAN OPENED THE MEETING AND STARTED WITH THE PUBLIC FORUM:**

- Speed limits and speeding vehicles through New Bolingbroke was questioned  
It was explained that this is a constant agenda item and that the council was trying for a speed reading.
- The members of the council were asked about the possibility of a play ground for small children and was there land other than the hidden area.  
It was stated that this could be a possibility if there was enough interest in the village and funding was found. Funding ideas were given by the District Councillor and it was mentioned that the football area in Carrington can be used by members of the public.
- It was asked if the phone box in New Bolingbroke could be used for the community  
Unfortunately, BT sold the phone box and the council cannot get an answer from the company that now owns it.
